Fax orders will be sent by 10:00 am the day after Budget Day

Courier orders in Toronto will receive the Budget Commentary before 5:00 pm the day after Budget Day. Courier orders outside Toronto will receive the Budget Commentary before 5:00 pm two days after Budget Day.

Pick-up orders will be available at the Institute of Chartered Accountants of Ontario office after 10:00 am the day after Budget Day.

Orders received on or after Budget Day will be fulfilled as soon as possible after all previous orders have been fulfilled.
